

# ZERO INCOME CERTIFICATION

## Virginia Rent and Mortgage Relief Program

- Alimony and child support payments (whether through the court system or not)
- Regular pay, special pay and allowances of a head of household or spouse who is a member of the Armed Forces (whether or not living in the dwelling)
- Regular monetary gifts from family and/or friends
